Each participant in a course or tour with Wasatch Whitewater understands and acknowledges that certain risks are integral or inherent to paddle sports and rafting, that staff is available to answer any questions about such risks, and that such risks may cause loss or damage to personal property, illness, accidental personal injury, or in some cases permanent trauma or death, including without limitation by way of example:
